### **Tuesday, July 13, 2010: Puppies, Puppies, Puppies!! – 4 months to 1 year**

- Topics include, but not limited to: building that fabulous working relationship w/your new agility partner we all want; how to create drive, drive and MORE drive, beginning contacts, entrances to weaves, tables, handling on the flat, , and control sprinkled throughout

### **Wednesday, July 14, 2010: Novice Handling and Problem Solving**

- For dogs ready to compete or competing at the Novice level. To fully participate, dogs must be competent on the 5'6" AFrame and all other competition equipment. If your dog lacks a complete skill on equipment, you may still register for a working spot, but you may audit any exercise your dog is not ready for. Use of some training aids (hoops, etc) may be permitted.
- In this session, Jen will help you strengthen your skills and/or deal with problems you have discovered as you start your dog's competitive career.

### **Thursday, July 15, 2010: Intermediate Handling**

- This session is for teams training at or competing at the Intermediate levels: AKC Open/Excellent A; NADAC Open; CPE level 3 and 4; USDAA Advanced
- Focus will be on improving independent equipment skills; tightening turns; course analysis and strategy; which cross to use when and much more
- To register for this session, dogs must be confident on a 5'6" AFrame and all other competition equipment. No training aids will be used.

### **Friday/Saturday, July 16/17, 2010: Large Dog Master's Handling**

- For dogs competing at the Masters/Excellent B level, jumping 20-26, with no motivation, control, focus or equipment problems or with TAG permission. Note: Priority registration will be given to those signing up for both days
- This session will focus on handling: We will be looking at tightening up crosses and turns; analyzing course challenges to select just the right handling move to shave fractions of seconds from your course times.
- Also great preparation for the AKC Nationals at the end of March!
- Preference will be given to those teams registering for both days or for two people signing up together, each working one day.

### **Sunday/Monday, July 18/19, 2010: Small Dog Master's Handling**

- Same curriculum as the large dog masters session but focusing on dogs jumping 16" and less.

**Cost:** (includes continental breakfast for the morning sessions and snacks for the afternoon. Water will be available all day). There are many fast food restaurants within one mile of the site for lunch.
